THE RELATIONSHIP BETWEEN WAGE DIFFERENTIALS AND PRODUCTIVITY IN MANUFACTURING INDUSTRIES

The concept of “labor market flexibility” has been debating more intensively along with the Neo-liberal transformation around the world after the 1980s. In this research, relationship between wage differentials expected to represent it and productivity was trying to present in the manufacturing industries. With respect to that purpose, it has been handled two-digit sectors of OECD countries for the period 1990-2009. Findings, which were obtained from panel data models constituted by making use of Generalized Method of Moments (GMM), showed that increase of wage differentials creates negative impact on productivity in the most of the sectors with high-tech sectors. For low-tech industries, this relationship has been confirmed less frequently.

İMALAT SANAYİ SEKTÖRLERİNDE ÜCRET FARKLILIĞI VE VERİMLİLİK İLİŞKİSİ

“İşgücü piyasaları esnekliği” kavramı, 1980’lerden sonra dünyadaki Neo-liberal dönüşüm ile daha yoğun bir biçimde tartışılmaktadır. Bu araştırmada, imalat sanayii endüstrilerinde, kavramı temsil ettiği düşünülen ücret farklılıkları ile verimlilik arasındaki ilişki ampirik olarak ortaya konulmaya çalışılmaktadır. Bu amaçla OECD ülkelerinin iki dijital sektörleri 1990-2009 dönemi için ele alınmıştır. Genelleştirilmiş Momentler Metodu (GMM)’ndan yararlanılarak oluşturulmuş panel veri modellerinden elde edilen bulgular, yüksek teknoloji yoğunluğuna sahip sektörlerin çoğunda, ücret değişkenliğindeki artışın verimlilik üzerindeki negatif etki yarattığını göstermektedir. Düşük yoğunluklu sektörlerde ise bu ilişki daha az sıklıkta tespit edilmiştir.
